#### **B. YOUR RESPONSE TO SELECTION CRITERIA:**

1. Demonstration of your commitment to and interest in international development work.

- 2. Demonstration of your outstanding and appropriate leadership, teaching and personal skills. This includes a respect for cultural differences and an understanding of appropriate conduct/attitudes when working in the developing world.

#### For example:

- Your contribution to the ophthalmic and medical community, your university, place of work, general community and/or family in the last five years.
- Any teaching experience that you may have had.
- Any other experience, etc. that may be able to demonstrate your excellence in communication skills, both oral and written.
- Any other personal skills that you consider relevant e.g. resourcefulness, ability to work within a team and independently, adaptability, resilience, an ability to cope when outside your comfort zone.
- A demonstration of your understanding of cultural issues, sensitivities and appropriate conduct e.g. gender awareness, environmental issues, when working in the developing world.
- 3. Establishment of the ongoing benefits of the Scholarship both personally and to the practice of internationally ophthalmology

#### For example:

- Demonstration of the benefits of the Scholarship to you.
- Other than the benefits flowing on from the Scholarship, details of any other benefits that may flow to the practice of ophthalmology in the developing world (i.e. what you could bring to the practice of international ophthalmology whether in Switzerland or internationally that has not already been covered in your application e.g. presentations, involvement in CODC or other such committees, etc.).
